

**CHILLING AFFAIRS CC ABBREVIATED CONDITIONS OF HIRE OF MOBILE REFRIGERATION UNITS ("the Unit")**

1. The customer hereby hires the Unit/s from Chilling Affairs. The customer shall take delivery of, operate and care for, and punctually return the Unit/s to Chilling Affairs in accordance with the terms, times and dates specified below.
2. Notwithstanding that ownership of the Unit/s shall at all times remain vested in Chilling Affairs, the customer shall be solely liable for all risk of loss in and damage to the Unit from the time that it takes delivery thereof until safe return to Chilling Affairs. The customer hereby indemnifies and holds Chilling Affairs harmless against any and all loss, damage or claims, of whatsoever nature, arising from the customer's rental of the Unit/s.
3. The customer acknowledges that it has taken delivery of the Unit/s in full and good working order and condition and shall return the Unit/s to Chilling Affairs punctually as agreed in the same working order and condition. The customer shall be liable to Chilling Affairs for any and all damage caused to, as well as for any speeding or other traffic violation fines levied in respect of, the Unit/s while in the possession of the customer, and shall pay for any and all such damages and/or fines on demand. The customer specifically authorises Chilling Affairs to deduct any such amounts in respect of damages and/or fines from any deposits held by Chilling Affairs on behalf of the customer.
4. The customer shall exercise the utmost care when transporting and using the Unit/s, and shall ensure that the Unit/s are at all times kept, clean, safe and secure.
5. The customer acknowledges that it has been instructed on the operation of the Unit/s and undertakes at all times to operate the Unit/s strictly in accordance with such operation instructions and with a view to preserving and protecting the Unit/s. The customer shall specifically ensure that the thermostats are operated, monitored and regulated in accordance with operating instructions. Should the customer have any concern that the Unit/s are not functioning correctly, it shall immediately contact Chilling Affairs on one of the 24-hour contact numbers provided in order that Chilling Affairs may despatch the necessary service team.
